CONTRACT AGREEMENT

THIS AGREEMENT, made this 11th day of August 2023 between Government of the Republic of the Philippines, through **Municipality of San Marcelino**, represented by the Hon. Mayor **ELMER RAGADIO SORIA** (hereinafter called the "Entity") and **AKPSN BUILDERS AND SUPPLY** represented by **KENNETH S. PASION** (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute "*Rehabilitation and Improvement of Multi-Purpose Building at Various Barangays: (a) Rehabilitation of Comfort Rooms at the Multi-Purpose Building of Barangay Central (b) Improvement of Multi-Purpose Building at Barangay Rizal (c) Improvement of Multi-Purpose Building at Barangay San Guillermo, San Marcelino, Zambales*", Project ID No. Infra-2023-020 (hereinafter called "*the Works*") and the Entity has accepted the Bid for **ONE MILLION NINE HUNDRED NINETY THOUSAND PESOS (PHP 1,990,000.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- a. Performance Security;
- b. Notice of Award of Contract and the Bidder's conforme thereto; and
- c. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **ONE MILLION NINE HUNDRED NINETY THOUSAND PESOS (PHP 1,990,000.00)** or such other sums as may be ascertained, **AKPSN BUILDERS AND SUPPLY** represented by **KENNETH S. PASION** agrees to "*Rehabilitation and Improvement of Multi-Purpose Building at Various Barangays: (a) Rehabilitation of Comfort Rooms at the Multi-Purpose Building of Barangay Central (b) Improvement of Multi-Purpose Building at Barangay Rizal (c) Improvement of Multi-*


