CONTRACT AGREEMENT

THIS AGREEMENT, made this 29th day of November 2023 between Government of the Republic of the Philippines, through Municipality of San Marcelino, represented by the Hon. Mayor ELMER RAGADIO SORIA (hereinafter called the "Entity") and BERZAN ENTERPRISE REPRESENTED BY GLYZEL A. BERMEJO- Owner (HEREINAFTER CALLED "THE SUPPLIER") OF THE other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly "Supply and Delivery, Installation and Upgrading of CCTVs at Municipal Public Market and Municipal Hall, San Marcelino, Zambales" Project ID No. Goods-2023-018 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of ONE MILLION FIVE HUNDRED NINETY NINE THOUSAND FIVE HUNDRED PESOS (Php1,599,500.00) (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation:

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of ONE MILLION FIVE HUNDRED NINETY NINE THOUSAND FIVE HUNDRED PESOS (Php1,599,500.00) or such other sums as may be ascertained, BERZAN ENTERPRISE represented by GLYZEL A. BERMEJO- Owner agrees to "Supply and Delivery, Installation and Upgrading of CCTVs at Municipal Public Market and Municipal Hall, San Marcelino, Zambales" in accordance with his/her/its Bid.
