INVITATION TO BID

**“CONSTRUCTION OF RETAINING WALL, SLOPE PROTECTION AND CONCRETING OF SHOULDER AT VARIOUS BARANGAYS”**

1. The LGU of San Marcelino, Zambales through the **5% LDRRM FUND & 20% DEV'T FUND** intends to apply the sum of **Three Million Pesos (Php3,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **“CONSTRUCTION OF RETAINING WALL, SLOPE PROTECTION AND CONCRETING OF SHOULDER AT VARIOUS BARANGAYS: (a) Construction of Slope Protection and Concreting of Shoulder along Nagcabitinian Rd., Brgy. San Isidro (b) Construction of Slope Protection and Road Concreting with Shoulder along Main Irrigation Canal, Brgy. San Isidro (c) Construction of Retaining Wall at a Box Culvert Bridge Approach in Brgy. Lucero, San Marcelino, Zambales”**, **Project ID No. Infra-2024-01**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Municipality of San Marcelino, Zambales BAC now invites bids for the Contract/project: for the **CONSTRUCTION OF RETAINING WALL, SLOPE PROTECTION AND CONCRETING OF SHOULDER AT VARIOUS BARANGAYS: (a) Construction of Slope Protection and Concreting of Shoulder along Nagcabitinian Rd., Brgy. San Isidro (b) Construction of Slope Protection and Road Concreting with Shoulder along Main Irrigation Canal, Brgy. San Isidro (c) Construction of Retaining Wall at a Box Culvert Bridge Approach in Brgy. Lucero, San Marcelino, Zambales**. Completion of the Works is required for **60 Calendar Days**.
3. Bidders should have completed, within Ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents particularly, in Section II, instruction to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as The Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138. Interested bidders should be enrolled in the Electronic Filing and Payment System (eFPS) program of the Bureau of Internal Revenue (BIR), pursuant to Executive Order No. 398, RR 3-2005, and must be registered under the Philippine Government Procurement System (PhilGEPS).

5. Interested bidders may obtain further information from the Municipality of San Marcelino, Zambales and inspect the Bidding Documents at the address given below from Monday to Friday 8:00 AM to 5:00 PM.

A complete set of Bidding Documents may be purchased by interested Bidders starting **February 8-27, 2024** from the address below and upon payment of a non-refundable fee for the Bidding Documents of **Five Thousand Pesos (Php 5,000.00)**.

6. The Municipality of San Marcelino will hold a Pre-Bid Conference on **February 14, 2024, 9:00 AM** at the BAC Office, San Marcelino, Zambales which shall be open to all interested parties.

7. Bids must be delivered to the address below on or before **February 28, 2024, 8:30 AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB clause 18.

Bid opening shall be **February 28, 2024, 9:00 AM** at the BAC Office, San Marcelino, Zambales.
