



WHEREAS, in response to the said advertisement, the interested supplier whose submission is determined as the successful offer submitted the requirements and was found or declared eligible;


WHEREAS, the quotation submitted on **March 24, 2024** was found to be responsive and passed the preliminary examination of documents;




