CONTRACT AGREEMENT

THIS AGREEMENT, made this 31st day of March 2025 between Government of the Republic of the Philippines, through Municipality of San Marcelino, represented by the Hon. Mayor ELMER RAGADIO SORIA (hereinafter called the "Entity") and SIM Computer Sales, Inc. represented by GERRY REYES- Commercial Account Manager (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly "PROCUREMENT OF LEGISLATIVE MANAGEMENT SYSTEM SUBSCRIPTION SERVICES FOR SAN MARCELINO, ZAMBALES SB OFFICE 2025" Project ID No. Goods-NP-2025-001 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of NINE HUNDRED FIFTY THOUSAND PESOS (Php950,000.00) (hercinafter called "the Contract Price").

 - Supplemental or Bid Bulletins, if any iv.
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation:

- Notice of Award of Contract; and the Bidder's conforme thereto; and iv.
- Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of NINE HUNDRED FIFTY THOUSAND PESOS (Php950,000.00) or such other sums as may be ascertained, SIM Computer Sales, Inc. represented by GERRY REYES agrees to "PROCUREMENT OF LEGISLATIVE MANAGEMENT SYSTEM ANNUAL SUBSCRIPTION SERVICES FOR SAN MARCELINO, ZAMBALES SB OFFICE 2025" in accordance with his/her/its Bid.

The Municipality of San Marcelino, represented by the Hon. Mayor ELMER RAGADIO SORIA agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
