WHEREAS, the Municipality of San Marcelino acknowledges the need to upgrade its current Emergency Communications System to better serve the community and enhance disaster risk reduction and management efforts;

WHEREAS, the Municipality of San Marcelino recognizes the financial constraints in acquiring and installing a new Emergency Communications System without external assistance;

WHEREAS, the Municipality of San Marcelino acknowledges the availability of the Zamboanga Financial Assistance for the purchase of supplies / equipment of MDRRMC previously recorded at GF (08/2012) amounting to Php 500,000.00 to support local government units in enhancing their disaster preparedness and response capabilities;

WHEREAS, the Municipality of San Marcelino deems it necessary to utilize the financial assistance under the Zamboanga Financial Assistance Program for the Purchase and Installation of the Emergency Communications System;


WHEREAS, the Municipal Disaster Risk Reduction and Management Council (MDRRMC) has conducted thorough assessments and consultations regarding the technical specifications, cost estimates, and benefits of upgrading the Emergency Communications System;

NOW, THEREFORE, be it resolved, as it is hereby resolved by the Municipal Disaster Risk Reduction and Management Council (MDRRMC) of San Marcelino, Zambales, that:


1. The proposed budget for the Purchase and Installation of the Emergency Communications System, amounting to Php 500,000.00, is hereby approved by the MDRRMC.
2. The MDRRMC shall monitor and oversee the progress of the project, ensuring its timely and efficient completion.

This Resolution shall take effect immediately upon approval.
