**RESOLUTION ON THE MANIFESTATION OF SUPPORT OF SAN MARCELINO MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (SAN MARCELINO MDRRMC), TO THE HOUSE SUBSTITUTE BILL ON THE MAGNA CARTA FOR PUBLIC DISASTER RISK REDUCTION AND MANAGEMENT WORKERS IN THE 19TH CONGRESS**

**WHEREAS**, Republic Act (RA) No. 10121, otherwise known as the “**Philippine Disaster Risk Reduction and Management Act of 2010**”, was enacted into law on 27 May 2010, which aims to strengthen the disaster risk reduction and management system of the country;

**WHEREAS**, the National Disaster Risk Reduction and Management Council issued Memorandum Circular No. 07, s. 2023 regarding the **Manifestation of Support to the House Substitute Bill on the Magna Carta for Public Disaster Risk Reduction and Management (DRRM) Workers in the 19th Congress**;

**WHEREAS**, the House Substitute Bill on the Magna Carta for Public DRRM Workers aims to provide support and recognition for the invaluable contributions of DRRM workers in safeguarding lives, livelihoods, and properties in times of disasters and emergencies;

**WHEREAS**, the protection and welfare of DRRM workers are essential for ensuring effective disaster response and resilience building within our communities;

**WHEREAS**, the enactment of this Bill shall establish clear guidelines and mechanisms for the protection of DRRM workers’ rights, including provisions for fair compensation, training, and career development opportunities among others;

**WHEREAS**, supporting the said House Substitute Bill aligns with the commitment of San Marcelino MDRRMC, in upholding the welfare and dignity of all individuals involved in disaster response and resilience efforts;

**RESOLVED AS IT IS HEREBY RESOLVED**, that the San Marcelino MDRRMC hereby manifests its support to the House Substitute Bill on the Magna Carta for Public Disaster Risk Reduction and Management Workers in the 19th Congress;
