WHEREAS, the Municipality of San Marcelino, Zambales, recognizes the need to address the impact of Typhoons Egay, Falcon, and the Enhanced Southwest Monsoon in August 2023 on various infrastructures, particularly the access road at Sitio Palien, Brgy. Buhawen, which suffered significant damage;

WHEREAS, the Municipal Disaster Risk Reduction and Management Fund Investment Plan (MDRRMFIP) for the fiscal year 2023 has unexpended balances amounting to Php 1,897,462.51, which can be reallocated for urgent repair and improvement projects;

WHEREAS, it is imperative to take proactive measures to prevent further deterioration of the access road at Sitio Palien, which connects Brgy. Buhawen to the Poblacion of San Marcelino, ensuring continued accessibility for residents to vital commodities and services;

WHEREAS, the utilization of the said fund for the repair and improvement of the access road at Sitio Palien is deemed necessary to mitigate risks and prevent isolation of Brgy. Buhawen from essential services;

WHEREAS, the Municipal Disaster Risk Reduction and Management Council (MDRRMC) recognizes the urgency of the situation and the need for immediate action to address the concerns of the affected community;


WHEREAS, this Resolution is in compliance with **COA Circular No. 2021-002**, ensuring transparency, accountability, and proper documentation of fund utilization;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the Municipal Disaster Risk Reduction and Management Council (MDRRMC) of San Marcelino, Zambales, to reprogram the F.Y. 2023 unexpended balances of the Municipal Disaster Risk Reduction and Management Fund Investment Plan (MDRRMFIP) transferred to the Special Trust Fund amounting to Php 1,897,462.51 for the repair and improvement of access road at Sitio Palien, Brgy. Buhawen, in consideration of the reasons stated above.


RESOLVED FURTHER, that copies of this Resolution be furnished to the Municipal Mayor, Sangguniang Bayan, Municipal Planning and Development Office (MPDO), Municipal Treasurer's Office, and other relevant offices for their information and appropriate action.
