APPROVAL OF THE PROJECTS, PROGRAMS, AND ACTIVITIES (PPAs) FOR THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT INVESTMENT FUND PLAN (MDRRMFIP) FOR INCLUSION IN THE COMPREHENSIVE DEVELOPMENT PLAN (CDP) CY 2025-2030 OF THE MUNICIPALITY OF SAN MARCELINO, ZAMBALES

WHEREAS, the Municipality of San Marcelino, Zambales recognizes the importance of disaster risk reduction and management (DRRM) in safeguarding the lives, properties, and livelihoods of its constituents;

WHEREAS, the Municipal Disaster Risk Reduction and Management Council (MDRRMC) is mandated to formulate and implement DRRM plans and programs in accordance with Republic Act No. 10121, otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010";

WHEREAS, the MDRRMC has conducted thorough assessments, consultations, and evaluations to identify priority projects, programs, and activities (PPAs) that are essential in enhancing the municipality's disaster resilience and response capabilities;

WHEREAS, the proposed PPAs are aligned with the goals, objectives, and strategies outlined in the Municipal Disaster Risk Reduction and Management Investment Fund Plan, aiming to mitigate risks, strengthen preparedness, improve response mechanisms, and facilitate recovery and rehabilitation efforts in times of disasters;

WHEREAS, the inclusion of these PPAs in the Comprehensive Development Plan CY 2025-2031 signifies the municipality's commitment to sustainable development, resilience building, and community empowerment in the face of natural and man-made hazards;

WHEREAS, the MDRRMC has reviewed and deliberated on the proposed PPAs, taking into consideration the inputs and recommendations from various stakeholders, experts, and technical personnel;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Municipal Disaster Risk Reduction and Management Council (MDRRMC) of San Marcelino, Zambales, in a meeting duly assembled:

1. That the proposed Projects, Programs, and Activities (PPAs) under the Municipal Disaster Risk Reduction and Management Investment Fund Plan are approved for inclusion in the Comprehensive Development Plan CY 2025-2030 of the Municipality of San Marcelino, Zambales;
2. That the implementation of these approved PPAs shall be carried out in accordance with the timelines, budgetary allocations, and monitoring mechanisms specified in the Municipal Disaster Risk Reduction and Management Investment Fund Plan;
3. That the MDRRMC shall oversee and coordinate the execution of the approved PPAs, ensuring transparency, accountability, and efficiency in resource utilization and project delivery;
4. That continuous evaluation, review, and enhancement of the DRRM plans and programs shall be conducted to address emerging risks, technological advancements, and changing socio-economic conditions;
