A RESOLUTION APPROVING THE ADDITIONAL FUNDING OF THE 5% MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PLAN (MDRRMFIP) F.Y. 2024 DUE TO A NEW REVENUE SOURCE AMOUNTING TO P235,000.00, AND PROGRAMMING IT UNDER THE CURRENT PPA OF THE "CONDUCT OF CAPACITY DEVELOPMENT PROGRAMS ON ICS, GAWAD KALASAG, NDRM, DISASTER MITIGATION AND PREVENTION, DISASTER PREPAREDNESS, DISASTER RESPONSE, AND DISASTER REHABILITATION AND RECOVERY, AND UPDATING OF DRRM-CCA PLANS" UNDER THE DISASTER PREPAREDNESS THEMATIC AREA

WHEREAS, Republic Act No. 10121, otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010," mandates the allocation of at least 5% of the local government's annual budget as the Local Disaster Risk Reduction and Management Fund (LDRRMF) to support disaster risk reduction and management activities;

WHEREAS, the Municipal Disaster Risk Reduction and Management Council (MDRRMC) of San Marcelino has previously approved the Municipal Disaster Risk Reduction and Management Fund Investment Plan (MDRRMFIP) for Fiscal Year 2024, which details the allocation of funds for disaster preparedness, response, rehabilitation, and recovery programs;

WHEREAS, due to a new revenue source, the Municipality of San Marcelino has secured additional funding amounting to Two Hundred Thirty-Five Thousand Pesos (P235,000.00), which is to be allocated under the 5% MDRRM Fund for F.Y. 2024;

WHEREAS, the MDRRMC recognizes the need to prioritize the effective utilization of this additional funding by programming it under the existing "Conduct of Capacity Development Programs on ICS, Gawad Kalasag, NDRM, Disaster Mitigation and Prevention, Disaster Preparedness, Disaster Response, and Disaster Rehabilitation and Recovery and Updating of DRRM-CCA Plans" under the Disaster Preparedness Thematic Area, to strengthen the municipality's capacity for disaster management and climate change adaptation;

WHEREAS, the allocation of this additional P235,000.00 for the said programs will further enhance the municipality's preparedness, response, and recovery capabilities, aligning with the national government's goals for resilient and disaster-ready local government units;

WHEREAS, it is necessary for the MDRRMC to endorse the approval of the additional funding to the Sangguniang Bayan and other concerned offices for formal disposition and inclusion in the MDRRMFIP F.Y. 2024;

NOW, THEREFORE, on motion of Ms. Leah C. Villajuan, duly seconded by Ms. Eleanor A. Damasco, be it:


