RESOLUTION LIFTING THE STATE OF CALAMITY IN THE MUNICIPALITY OF SAN MARCELINO, ZAMBALES

WHEREAS, Typhoons Egay and Falcon, along with the Enhanced Southwest Monsoon, caused severe adverse impact to the Municipality of San Marcelino, Zambales;

WHEREAS, recognizing the gravity of the situation, the Sangguniang Bayan of San Marcelino issued Resolution No. 2023-110 on 04 August 2023, declaring the State of Calamity in the municipality to facilitate effective response and recovery efforts;

WHEREAS, pursuant to NDRRMC Memorandum Order No. 60, Series of 2019, the termination of a state of calamity may be recommended based on criteria such as the restoration of normalcy in the affected areas, availability of essential services, and capability of the LGU to address community needs;

WHEREAS, the Municipality of San Marcelino, under the leadership of the LGU and the Municipal Disaster Risk reduction and Management Council (MDRRMC), spearheaded immediate response and remedial measures to mitigate the impacts of the calamities;

WHEREAS, through the collective efforts of the LGU, with the MDRRMO at the forefront, significant progress has been made towards the fast recovery and rehabilitation of the municipality;

WHEREAS, continuous monitoring and assessment by the MDRRMC have shown substantial improvements in the overall situation, including the restoration of essential services and infrastructures;

WHEREAS, consultations with relevant agencies and stakeholders have been conducted in accordance with NDRRMC Memorandum Order No. 60, ensuring coordination and support for the termination/lifting of the State of Calamity;

WHEREAS, forwarded to the Sangguniang Bayan for review and consideration is MDRRMC Resolution No. 08, Series of 2024 recommending the termination/lifting up the State of Calamity in the Municipality of San Marcelino declared on August 4, 2023;

WHEREAS, in a regular session assembled, the MDRRMO recommendation was deliberated and no objection was interposed;


WHEREFORE, premises considered, on motion of Hon. Mario F. Cabbab seconded by Hon. Manuel P. Arquero, Jr.;

RESOLVE, as it is hereby **RESOLVED** to LIFT as it is hereby LIFTED the State of Calamity in the Municipality of San Marcelino, Zambales;

RESOLVED FURTHER, to furnish copy of this resolution to all concerned for information and record;

ADOPTED on July 8, 2024.




